The Chief Engineer, Roads, vide letter read 2nd above, has submitted a restoration estimate for arranging the restoration works along MC road from Thycode to Ambalamukku from Ch: 25/250 to 30/870 for Rs 3,05,47,800/- in connection with road cutting for the JJM pipeline work and requested to accord Administrative Sanction. The Chief Engineer has also informed that the Kerala Water Authority remitted an amount of Rs. 3,05,63,074/- for restoration and the restoration estimate is prepared for providing interlock and concrete since it is difficult to arrange the bituminous work for a limited width. The Chief Engineer, KSTP, vide letter read 3rd above, requested accord Administrative Sanction under the KSTP's Head of account 5054-03-337-97(PV).

Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of Rs 3,05,47,800/-(Rupees Three Crore Five Lakh Forty Seven Thousand and Eight Hundred only) for the restoration work of Kerala Water Authority pipe laid portions under Jal Jeevan Mission from Thycode to Ambalamukku(MC Road) from Ch: 25/250 to 30/870 under the head of
