2. As per Govt Order read as forth above, detailed guidelines have been issued by Government regarding prioritization of plan fund for the year 2024-25 ordering to cut down 50 % of total plan outlay and to revise the Administrative Sanction accordingly.

3. Based on the said guidelines, the Director of Survey & Land Records, as per letter read as fifth above, furnished a proposal for Plan Prioritization limiting the expenditure by 50% and the same was considered by the Committee chaired by the Chief Secretary in the meeting held on 17.12.2024 and the committee agreed to retain the entire plan outlay subject to the condition that Administrative Sanction shall be issued only for 50% of the total plan outlay for the time being and for the balance 50% AS can be issued after one month.
