ORDER

Government have accorded administrative sanction for the procurement of one Interceptor Boat for an amount of Rs.3 Crore under the State Plan Scheme for the year 2025-26 as per Government Order read as 1st paper above. The State Police Chief, as per letter read as 2nd paper above, has informed that the specification of the Interceptor Boat has been prepared accordingly by a specification committee headed by AIG, Coastal Security. Based on that specification, e-tender was invited for the purchase of one Interceptor Boat and two firms were participated in the e-tender i.e, M/s. Steel Industrials Kerala (SILK) Ltd. and M/s. Sea Ray Marine Equipment and Spares LLP, Kozhikode. The Technical Evaluation Committee constituted under the IGP, Coastal Security evaluated all the specifications as per the tender submitted by the firms, with the prerequisite specifications for procuring the interceptor boat given by the department.

2) The Committee after detailed and careful technical evaluation recommended that M/s. Steel Industrials Kerala Ltd is qualified in the technical evaluation. The Financial Evaluation Committee has reported that

the firm M/s. SILK Ltd. quoted L1 rate of Rs.2,35,20,000/- inclusive of GST, for one Interceptor Boat. The State Police Chief has therefore requested to convene the Departmental Purchase Committee meeting for the consideration of the above proposal and accord sanction for the purchase of one Interceptor Boat from M/s. Steel Industrials Kerala Ltd. at a total cost of Rs.2,35,20,000/- by meeting the expenditure from the head of account 2055-00-115-98-(28)-PV under State Plan Scheme for the year 2025-26.

3) The Departmental Purchase Committee Meeting chaired by the Additional Chief Secretary (Home & Vigilance), held on 02.12.2025, considered the proposal of the State Police Chief and decided to accept the proposal and has recommended the purchase of one Interceptor boat from M/s. Steel Industrials Kerala Ltd. at a total cost of Rs.2,35,20,000/-.

4) Government have examined the matter in detail and are pleased to accord sanction for the purchase of one Interceptor boat from M/s. Steel Industrials Kerala Ltd. at a total cost of Rs.2,35,20,000/- (Rupees Two Crore Thirty Five Lakh and Twenty Thousand Only) by meeting the expenditure from the head of account 2055-00-115-98-(28)-PV, as sanctioned under the State Plan Scheme for the year 2025-26, subject to observance of relevant rules, regulations and procedural formalities in this regard.
