**ORDER**

Kerala State Women's Development Corporation has a total budget allocation of Rs.110 lakh under the H/a: 2235-02-103-90(2) for the Flagship Programme on Gender Awareness in the Financial Year 2025-26. Out of the same, Government have accorded sanction for an amount of Rs.88 lakhs for the implementation of various projects under this schemes as per G.O.read as 1<sup>st</sup> paper above and an amount of Rs.38.50 lakhs were released against this as per G.O.read as 3<sup>rd</sup> paper above. In the FY 2024-25, the Government released an amount of Rs.55 lakhs in two instalments for the implementation of Flagship Programme on

Gender Awareness (H/a: 2235-02-103-90(02)) to the PSTB A/c No. 512 with the District Treasury, Thiruvananthapuram. The Government resumed Rs.22 Lakhs from this head of Account at the close of the financial year 2024-25, which was reallocated and released from the current year's budget as per G.O. read as 2<sup>nd</sup> paper above.

2. The instructions in Circular No.84/2008/Fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
3. The Managing Director, Kerala State Women's Development Corporation shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in G.O(Ms)No.4/2020/Fin dated 09/01/2020.
4. If there is un-utilized amount at the end of this financial year that

should be refunded to the government during the financial year itself.
