ORDER

As per Government Order read as Ist paper above, Administrative Sanction was accorded for utilizing an amount of Rs.2 crore for "Women Entrepreneurship Mission(WEM Mission)" - Financial Assistance Scheme

for scaling up of the business ventures of the women entrepreneurs in the state, by meeting the expenditure from the head of account "2885-60-190-91 PV". During the surge of 2nd wave of Covid-19 pandemic period, a relief package called "Covid 19 Samashwasa Package" was introduced in the state to assist Industrial Units, vide Government Order read as 2nd paper above. As per Government Order read as 3rd paper above, Administrative sanction was accorded for the scheme "Innovation Acceleration Scheme" (Continuing Scheme) for an amount of Rs 11 crore under the head of account "2885-60-190-91 PV". As per Government Order read as 4th paper above, Administrative sanction was accorded for the scheme "Investment Facilitation & Industrial Promotion Activities" (Continuing Scheme) for an amount of Rs 13 crore under the head of account "2885-60-190-91 PV". Besides this, vide Government Order read as 5th paper above, Administrative Sanction was accorded for the project "Chief Minister's Special Assistance Scheme for MSMEs/StartUps, Micro Enterprises and NRKs and Working Capital Loan Scheme for Micro Enterprises" for an amount of Rs.3 Crore by re-appropriating an amount of Rs.1 Crore (Rupees One Crore Only) each from the schemes viz. Investment Facilitation & Industrial Promotion Activities, Innovation Acceleration Scheme and Women Entrepreneurship Mission modifying the Government Orders read as 1st, 3rd and 4th paper above to the above extent .

2) Meanwhile, Managing Director, Kerala State Industrial Development Corporation Limited, (KSIDC) vide his letter read as 6th paper above has furnished Annual Plan Project proposal called "Covid 19 Samashwasa Package" with an objective for promotion and development of MSME units in the State in line with the relief measures proposed in the Covid 19 Samaswasa Padhathi and requested to accord Administrative Sanction for an amount of Rs.5 crore (Rupees Five crore only) for the scheme. Moreover, Managing Director, Kerala State Industrial Development Corporation Limited, (KSIDC) vide letter read as 8th paper above has also furnished a proposal for re-appropriation to the tune of Rs.2.50 crores each from the schemes viz. Investment Facilitation &

Industrial Promotion Activities and Innovation Acceleration Scheme respectively since budget provision was not allocated for the scheme. The above scheme was considered by the 8th Departmental Working Group Meeting held on 15.01.2022 and recommended to issue Administrative Sanction for the same .

3) The Component Wise break up of the scheme is as follows :

3) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the scheme "Covid-19 Samashwasa Package" for an estimate amount of Rs.5 crores (Rupees Five crores only) under the Head of Account "2885-60-190-91 PV" by meeting the fund requirement through re-appropriation to the tune of Rs.2.5 crore (Rupees Two crore Fifty lakh only) each from the schemes "Investment Facilitation and Industrial Promotion Activities" and "Innovation Acceleration Scheme" respectively.


