**ORDER**

The Chief Executive Officer, M/s.Techgentsia Software Technologies Pvt.Ltd as per letter read above has submitted a proposal offering the technology solution for Video Conference as V-Consol platform for use by Government of Kerala. The compensation sought by M/s Techgentsia for perpetual license to the State Government is the rent free functional space for their use in Infopark at Kochi/Cherthala which ab inito is assessed as rental income loss of ₹ 1.35 crore per annum for rental receivable by Infopark, Cherthala on current rate card for 25000 sq. feet making it 31 years valuation when compared to the price offered by M/s.Techgentsia Software Technologies for their VC solution of GeM platform. There are additional costs to be borne by the Government for operation of functional VC platform as well. However, during negotiations with CEO of M/s Techgentsia it has been arrived that they would limit their space requirement to 15000 sq feet built up space @ 7500 sq feet each in Infopark,Cherthala -plug and play space and Infopark phase II in Kochi- warm cell.

Government have examined the matter and are pleased to constitute a committee with following composition for finalizing commercial, and technical terms and conditions for using V Consol Video Conference platform by Government of Kerala.
