The appointment will be subject to verification of character and antecedents. If the verification reveals any adverse information, the appointment will be liable for termination without notice. As per GO(Ms)No.170/74/PD dated 18/07/1974, the Principal, Govt. Homoeopathic Medical College, Kozhikkode will obtain necessary details of the candidate, duly filled up in the prescribed proforma and will make necessary arrangement for verification of character and antecedents of the candidate.

3) The candidate shall report for duty before the Principal, Government Homoeopathic Medical College, Kozhikkode within 15 days from the date of receipt of this order with the following documents

- I. Certificates to prove qualifications, Date of Birth, Community, Non-creamy layer certificate and Service Certificate (if applicable).
- II. Certificate of medical fitness from a medical officer not below the rank of Civil Surgeon (with the thumb impression and attested Photo of the candidate should be affixed in the Certificate) as prescribed in G.O(P)No.20/11/P&ARD dt.30/06/2011

4) If the candidate fails to join duty within the prescribed time limit, the appointment order will be cancelled and the matter will be reported to the Kerala Public Service Commission.

5) If the candidates need extension of joining time, the application for the same should be submitted before the authority as per the conditions and time limit specified in the GO(P) No.15/2020/P&ARD dated 28/10/2020.

6) The date of joining of the candidate /entitlement register shall be informed to the Government, Accountant General (A&E) and the Secretary, Public Service Commission within one week of joining duty. The Principal & Controlling Officer shall forward 3 copies of RTC, Appendix I and Personal Memorandum received from the candidate for PSC/Police verification. The appointment shall be regularized only after the receipt of verification certificate from KPSC and police authorities.

7) After the candidate is allowed to join duty, the original One Time Verification Certificate shall be kept under the custody of the Principal, Government Homoeopathic Medical College, Kozhikkode. The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission. For this purpose the Principal, Government Homoeopathic Medical College, Kozhikkode shall forward an attested copy of the relevant pages of the Service book of the incumbent to Government as ordered in GO(P) No.20/2011/P&ARD dated 30/06/2011 along with the Original One Time Verification Certificate after recording necessary entries on the 2nd page. After making necessary entries at the time of Appointment Verification, the Original One Time Verification Certificate will be returned along with the Appointment Verification Certificate and both Certificates should be pasted in the Service Book of the incumbent.

8) The original verification certificate should be submitted to Government after verifying the signature and photo of the candidate and making necessary entries on the back side of verification certificate with office seal as ordered in GO(P) No. 20/2011/P&ARD dated 30/06/2011. And also should send the attested copy of the Medical Certificate.

9) The Proforma for Police Verification and PSC Verification and the original verification certificate along with the necessary documents, should be submitted to the Government within 15 days of joining of the candidate.

10) If the candidate has not joined within the time limit, it must be reported to the Government immediately along with the original verification certificate.
