ORDER

As per the 1st paper read above, Ministry of Finance had approved the projects submitted by the State under Special Assistance to States for Capital Investment (SASCI) Scheme and released an amount of Rs. 529.50 Crore under Part-I (Untied) of SASCI 2024-25. Out of this an amount of Rs. 21 Crore was allotted for the construction of three fire stations in Wayanad.

As per the letter read as 2 nd paper above, Chief Engineer, Public Works Department (Buildings) has submitted an estimate for an amount of Rs. 700 Lakh for Construction of New Building for Fire Station at Thondernad, Mananthavady on the land identified. The proposed G+1 building has a plinth area of 876.78 square metres. Estimate was prepared using PAR 2019 to facilitate the issue of administrative sanction. Chief Engineer, Public Works Department (Buildings) has proposed to arrange the work in EPC mode owing to urgency.

Government have examined the matter in detail and are pleased to accord administrative sanction for the work 'Construction of new Building for Fire station at Thondernad, Mananthavady' at an estimated cost of Rs 700 Lakh on EPC mode under SASCI Scheme on the condition that detailed estimate shall be prepared based on prevailing DSR and that Technical Sanction shall be issued by PWD before inviting tenders. The procurement

of furniture, vehicles, etc. shall only be in compliance with the prevailing Government norms. The expenditure in this regard will be met from the head of account 5475-00-800-75 -Capital Projects for Reconstruction in Wayanad District.
