<u>ORDER</u>

As per the Government Order referred first paper above, Government have granted Administrative Sanction for conducting a LiDAR survey to develop drainage Master Plans for the towns of Harippad, Mavelikkara, Adoor, and Pathanamthitta, at a cost of Rs. 3,00,00,000/-, which will be debited under the head of account for RKI.

2. As part of this initiative, a 5-member Joint Implementation

Committee (JIC) has been constituted with the following members, including representatives from DLI 4 and DLI 7 teams of the Water Resources Department, to ensure effective monitoring and provide periodic updates to RKI:

3. But, the CEO, RKI as per third paper above, has informed the Chief that, Government as per Order read second paper above Engineer have granted Leave Without Allowance for study purpose to Sri. Ashok B. Jacob, Assistant Director, Hydrology, IDRB, Thiruvananthapuram, for the period from 01.01.2025 to 30.06.2028, to pursue a PhD program at the Department of Agricultural and Biological Engineering, Pennsylvania State University, USA. Therefore has proposed that Sri. Dr. Devarajan K., Assistant Director II, Coastal Engineering Division, KERI, has been nominated as the substitute to Sri. Ashok B. Jacob in the Joint Implementation Committee for the review of DLI4 works.

4. In these circumstances, as per the reference read as the fourth paper above, the Planning and Economic Affairs (RKI) Department has requested the reconstitution of the Joint Implementation Committee based on this nomination.

5. Government have examined the matter in detail and are pleased to reconstitute the Joint Implementation Committee with Sri. Dr. Devarajan K., Assistant Director II, Coastal Engineering Division, KERI, in place of Sri. Ashok B. Jacob, Assistant Director, Hydrology, IDRB, Thiruvananthapuram.
