ORDER

An amount of Rs.100 lakh was allocated in the State Budget under the Head of Account 4215-01-800-82-P(V) for implementation of the scheme 'Rejuvenation of Water bodies for ensuring Source Sustainability of Water Supply Schemes' for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.50.00 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.50.00 lakh. Out of this, an amount of Rs.50 lakh was released as per Government Order read as 3rd paper above.

As per letter read as 4th paper above, the Executive Director, Jalanidhi has informed that no amount could be incurred as expenditure and accordingly Rs.50.00 lakh was resumed by Government from the PSTSB Accounts of KRWSA. Executive Director has requested to release the resumed fund of Rs.50.00 lakh for the implementation of the scheme 'Rejuvenation of Water bodies for ensuring Source Sustainability of Water Supply Schemes'.

3. Government have examined the matter in detail and are pleased to release an amount of Rs.50.00 lakh as reallocation of resumed amount to KRWSA for the implementation of the scheme 'Rejuvenation of Water bodies for ensuring Source Sustainability of Water Supply Schemes' under the Head of Account 4215-01-800-82-P(V) subject to the terms and conditions of fund release stipulated in Circular read as 5th paper above.
