### <u>ORDER</u>

An amount of Rs.250 lakh was allocated in the State Budget under the Head of Account 4215-02-102-99-02-P-V for implementation of the scheme 'Grey Water Management in colonies of vulnerable groups' for the year 2024-25. As per Government Order read as 1<sup>st</sup> paper above, the estimated cost for the proposed programme is reduced to Rs.80.00 lakh. Subsequently, as per the Government Order read as 2<sup>nd</sup> paper above, the Administrative Sanction was accorded for the reduced amount of Rs.80.00 lakh. Out of this, an amount of Rs.80 lakh was released as per Government Orders read as 3<sup>rd</sup> & 4<sup>th</sup> papers above.

As per letter read as 5<sup>th</sup> paper above, the Executive Director, Jalanidhi has informed that only Rs.52.94 lakh was utilized as expenditure and accordingly Rs.27.06 lakh was resumed by Government from the PSTSB Account of KRWSA. Executive Director has requested to release the resumed fund of Rs.27,06,066/- for the settlement of pending bills in connection with the scheme 'Grey Water Management in colonies of vulnerable groups'.
