ORDER

An amount of Rs.6.00 lakh was allocated in the State Budget under the Head of Account 4215-01-102-90-(P) for implementation of the scheme 'Research & Development in Rural Water Technologies and Management' for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.3.00 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.3.00 lakh.
