ORDER

As per the Government Order read Ist paper above, Administrative sanction for an amount of Rs. Rs 13,00,00,000/-(Thirteen Crore only) has been accorded for the annual plan schemes of the Kerala Council for Historical Research for 2025-26 under the head of account 2202-80-004-86-00-36-Grant in Aid-(P).

2. As per the Government Order read 2nd paper above, an amount of Rs. 4,55,00,000/-(Rupees Four Crore Fifty Five Lakh only) has been released as the first installment of Grant in Aid for the annual plan schemes for 2025-26.

3. As per the letter read above, the Director, Kerala Council for Historical Research, has requested to release the balance amount of Grant-in-Aid for which administrative sanction has been accorded, for the completion of the approved Annual Plan schemes.

Government have examined the matter in detail and are pleased to release an amount of Rs.4,00,00,000/- (Rupees Four Crore only) as the 2nd installment of grant in aid support for the year 2025-26 to the Kerala Council for Historical Research under the head of account 2202-80-004-86-00-36-Grant in Aid-(P). The amount shall be credited to the PTSTB Account No. 799012700001706 of Kerala Council for Historical Research maintained at Sub Treasury, Vellayambalam

5. Director, Kerala Council for Historical Research shall furnish utilisation certificate of the amount before the next release.

6. The Director shall also take timely steps to furnish the audited accounts to the Government.
