<u>ORDER</u>

1.Managing Director kerala Water Authority as per letter read as 3rd paper above has submitted proposal for awarding the tender for an amount exceeding 9.70% above the approved TPAC of the work JICA Assisted Water Supply Project to Kozhikode Corporation and adjoining Panchayats -Instrumentation Works & SCADA, Supply of Electromagnetic Flowmeter, Butterfly valve and Automation" in Kozhikode district.

2. Administrative Sanction for the project was issued as per Government Order read as 1st paper above for an amount of Rs10.77 crore and Technical Sanction was issued on 2/3/2024 as per order read as 2nd paper above. No bidders responded to the first tender call and the work was retendered with due date on 28/06/2024 and a single offer received. The Special Committee for Prequalification Approval decided not to prequalify the single bidder. Only one bidder responded to the third tender call.The Special Committee for pre qualification approval met on 17/08/2024 decided not to pre-qualify the single bidder. In the 4th tender call, no bidders responded. Therefore, the work was re-tendered with due date on 18/09/2024 and again no bidders responded to the tender call. Therefore, the work was retendered with due date on 13/11/2024. Two bidders responded to the tender. Technical bid ws opened on 14.11.2024.

3. The Special Committee for Prequalification Approval met on 25.11.2024 and 28.11.2024 decided to pre-qualify M/s. Midland Engineering and Contracting Company, Door No.592A & 592B, Downhill PO, Malappuram .Details of the tender as follows;

4. The Superintending Engineer made negotiations with the single bidder to bring the quoted amount within DSR + 10% tolerance limit. Single bidder disagreed to reduce the rates quoted by him.

5. As per Government order read as 4th and 5th above, contract can be given to least of the above. ie. LMR rate at Rs.5,61,78,205/-

6. The tendering authority has informed that the TS estimate consisted mainly of SCADA related items, for which DSR items are not available. The Chief Engineer (NR) has reported that there is a very rare chance for getting a better offer on retendering. Therefore, the Managing Director, Kerala Water Authority informed that Chief Engineer has recommended that the rate quoted by the single bidder may be approved at the Negotiated Contract PAC of Rs.5,87,57,644/-, which is 4.59% above the LMR and 9.70% above the Tendered PAC.
