### ORDER

The Director Malabar Cancer Centre, as per letters read above, informed that the construction of the new Pediatric Oncology Block at Malabar Cancer Center had been completed and requested to sanction 159 posts to make it functional. It was also reported that the Governing Body meeting held on 24.01.2019 had approved the proposal. Director of Malabar Cancer Centre submitted the Manpower Statement in the prescribed format, along with the proposal. It was reported that the additional financial commitment for creating new posts as requested was Rs. 28,39,30,320/- for 5 years and this expenditure would be met from the own funds or other revenue source of Malabar Cancer Centre.

2. Subsequently, as directed by Government, the Director Malabar Cancer Centre submitted revised proposal reducing the number of posts to 108 and requested for creation of 108 posts, which were absolutely essential to start functioning of the block. The 108 posts which were found indispensable for the functioning of the Pediatric Block were as mentioned below:-
