ORDER

As per Government Orders read as 1st & 2nd papers above, administrative sanction was accorded for an amount of ₹218 Lakhs to the Handicrafts Development Corporation of Kerala Ltd. (HDCK) against the total project cost of Rs. 383 Lakhs for the project- New product development, Office automation, virtual exhibitions, CFC strengthening, etc. during the financial year 2022-23. Subsequently, an amount of ₹118 Lakhs was released as part of this sanction.

- 2.In the financial year 2023-24, as per Government Order read 3rd paper above Government accorded Revised Administrative Sanction for this project at an estimated cost of ₹ 2,65,00,000 (Rupees Two Crores and Sixty Five Lakhs only) and sanctioned the release limiting to an amount of ₹ 200 Lakhs (Rupees Two Hundred Lakhs only). As part of this, as per Government Orders read as 4th & 5th above, an amount of ₹ 150 Lakhs was released during 2023-24.
- 3.In the financial year 2024–25, as per Government Order read 6th paper above the Government accorded administrative sanction for this project at an estimated cost of ₹1,26,50,000. As part of this, as per Government Order read as 7th paper above, an amount of ₹100 Lakh (Rupees One Hundred Lakh only) was released during 2024–25 to HDCK as working capital assistance under H/A 6851-00-190-98-(P).
- 3.The Member Secretary, BPT, Thiruvananthapuram as per letter read as 8th paper above has recommended and forwarded a project proposal of Handicrafts Development Corporation of Kerala Ltd. for the revalidation of Administrative Sanction of the project proposal of New product development, Office automation, CFC strengthening under the Scheme 'Rejuvenation and Revival of Viable Public Sector Units' for an amount of ₹188 Lakh from the current year's(2025-26) budget provision under the H/A 6851-00-190-98-(P).
- 4. The Working Group Meeting of the Industries Department held on 30.04.2025 considered the above project proposal and recommended the revalidation of administrative sanction for a total estimated cost of ₹188 Lakh (Rupees One Hundred Eighty-Eight Lakh only) from the Plan Fund, limiting the expenditure to the current year's budget provision under H/A 6851-00-190-98-P.
