## **ORDER**

The Director of Industries & Commerce, Thiruvananthapuram, as per the letter read as the 1<sup>st</sup> paper above, forwarded a project proposal from the Handicrafts Development Corporation of Kerala Ltd. (HDCK) for the 'Modernization of the Common Facility Service Centre (CFSC) at Attakkulangara, Thiruvananthapuram' under the scheme "Establishment of Common Facility Service Centres for Handicrafts" for administrative sanction. The proposal seeks an amount of ₹12.5 Lakh from the current year's (2025–26) budget provision under the Head of Account 2851-00-104-86-P. The details are as follows:

- 2. An amount of ₹50 Lakh has been provided in the 2025–26 budget under the Head of Account 2851-00-104-86-P for the development and promotion of new designs, and the establishment and modernization of CFSCs under SURABHI, KADCO, HDCK, and KELPALM.
- 3. The estimated cost for the modernization work is ₹25,20,000. The proposal submitted by HDCK and recommended by the DIC seeks ₹12.5 Lakh in the current financial year, with the remaining amount proposed to be considered in the subsequent financial years. The project aims to modernize the CFSC to promote craft development and generate employment opportunities by providing proper facilities to the artisans. The facility will help artisans adapt to consumer preferences and contribute to increased sales of handicrafts in both domestic and international markets, thereby benefiting the handicraft sector of Kerala.
