ORDER

The Director of Industries & Commerce, Thiruvananthapuram, as per the letter read as the 1st paper above, forwarded a project proposal from the Kerala Artisans Development Corporation (KADCO) for Infrastructure Upgradation of Southern Regional Office of KADCO under the scheme 'Assistance to Apex Organizations in the Handicrafts Sector' for an amount of ₹12.5 Lakh from the current year's (2025–26) budget provision under the Head of Account 4851-00-104- 99-P, seeking administrative sanction. The details are as follows:

An amount of ₹50.00 Lakh is provided for the scheme in the 2025–26 budget under the Head of Account 4851-00-104-99-P, for extending capital assistance for technology upgradation, modernization, renovation, and other capital-intensive activities of SURABHI, HDCK, KELPAM, and KADCO. This also includes provisions for the renovation

of selected outlets. The proposed project aims to construct a building for the use of Gold appraiser training Institute, Umayanalloor ,Kollam. Area of the proposed RCC building is 42.11 sqm. This estimate includes provisions for water supply, sanitary arrangements and Electrification works. Total estimate cost comes to Rs.12,50,000- including 18% GST.

- 3. The Working Group Meeting of the Industries Department held on 30.04.2025 considered the above project proposal and recommended to accord administrative sanction for the implementation of the project at a total estimated cost of ₹12.5 Lakh (Rupees Twelve lakh and fifty thousand only) under H/A 4851-00-104-99-P, from the current year's budget provision.
- 4. In pursuance of the above, Government have examined the matter in detail and are pleased to accord administrative sanction for Infrastructure Upgradation of Southern Regional Office of KADCO under the scheme 'Assistance to Apex Organizations in the Handicrafts Sector' for an amount of ₹12.5 Lakh (Rupees Twelve lakh and fifty thousand only), from the Plan Fund, limiting the expenditure to the current year's (2025–26) budget provision under the Head of Account 4851-00-104-99-P.
- 5.The Managing Director, Kerala Artisans Development Corporation (KADCO), shall forward the proposal for release of funds at the appropriate time.
