## **ORDER**

Government as per Order read as 1st paper above have issued Prospectus for admission to B.Sc. Nursing Course for the Academic Year 2024-25. As per G.O read as papers cited as 2nd to 6th papers above, sanction was accorded to the Director, LBS Centre for Science & Technology for making allotment to the B.Sc Nursing course seats in Government colleges, colleges under Government controlled educational institutions viz. State Institute of Medical Education & Technology, Centre for Professional & Advanced Studies, Co-operative Academy of Professional Education and Malabar Cancer Centre and the Government merit seats in private self financing colleges. As per the letter read as 8th paper above, the Director of Medical Education has requested to increase the allotted seats of Laxmi Meghan College of Nursing, Kasaragod from 50 to 75 in light of the affiliation accorded by Kerala University of Health Sciences vide order cited as 7th paper above.

sanctioned for allotment in Laxmi Meghan College of Nursing, Kasaragod for 2024-25 academic year is revised as 75 and the Director, LBS Center for Science and Technology is directed to make allotment to 38 Government merit seats in the college.
