**ORDER**

As per the order read as 1st paper above, Administrative sanction was accorded to the Director of Tourism to expend an amount of ₹3,46,95,540/- (Rupees Three Crore Forty-Six Lakh Ninety Five Thousand Five Hundred and Forty Only) including GST for the project "Setting up of Tourism Investment Facilitation Centre - Engagement of Project Management Unit (PMU) and facilitation services", by meeting the expenditure from the funds available under the h/a 5452-01-101-99-00-34-03-PV Up gradation,Creation of Infrastructure and Tourism Amenities (Plan), limiting the expenditure to this year's budget provision.

2. Based on the orders issued in 2<sup>nd</sup> and 3<sup>rd</sup> papers above, the department had placed proposals that were prioritized for the FY 2024-25, before the Chief Secretary's Committee constituted as per the order read as 2<sup>nd</sup> paper above. The Chief Secretary's Committee meeting held on 04.10.2024 had approved the aforesaid project by limiting the Administrative Sanction amount to the tune of ₹

25,00,000/- including GST.(Rupees Twenty Five Lakhs only)

3. Government have examined the matter and are pleased to modify the Government Order read as 1<sup>st</sup> paper above, by limiting the Administrative Sanction amount to ₹ 25,00,000/-(Rupees Twenty Five Lakhs only ) including GST subject to the condition that the Director of Tourism shall proritize the components in a phased manner or by deleting/revising the components as per the requirement.

4. The Government Order read as 1<sup>st</sup> paper above, stands modified to the above extent only.
