ORDER

In the budget speech 2021-22, Government had announced a proposal for setting up of Liquid Medical Oxygen Plants in the State that would cater to the needs of the State for oxygen demand for health sector in the backdrop of Covid-19 pandemic in the State. Subsequently, Managing Director, Kerala State Industrial Development Corporation Limited (KSIDC) was accordingly authorized as per letter Ist cited to invite tender for setting up of Liquid Medical Oxygen Plants in the State. As per letter read as 2nd paper above, Managing Director, KSIDC had reported that the tender notice related to the above project was released in e-tender portal on 28.07.2021. Subsequently, as per letter read as 3rd paper above, Managing Director, KSIDC has reported that tenders have been received from two firms viz. M/s Manorama Oxygen Pvt Ltd & M/s.Ozone Gases Pvt Ltd , Ernakulam respectively in response to the tender floated for the proposed initiative. Moreover, he has reported that the aforementioned firms have submitted detailed proposal comprising specific support services required from the State Government for setting up of the above project .

(2) Government have examined the matter in detail and are pleased to constitute a Secretary Level committee comprising the following members for examining the specific support services sought by the qualified firms from Government for setting up of Liquid Medical Oxygen Plant in the State
