O R D E R

As per letter read as 3rd paper above Government of India had released the first installment of funds for an amount of ₹16.0001 lakhs under the scheme National Food Security Mission NFSM- (KL213) 2024-25 under the umbrella scheme Krishonatti Yojana with 60:40 sharing between the Centre and State for three components namely rice, pulses and nutri-cereals . As per Government order read as 4th paper above, the State Government has released the funds including Central and State share as additional authorization to the existing heads for Rice and Pulses component and to the new heads created for Millets component.

2. Director of Agriculture as per letter read as 5th paper above has informed that since Mother Sanction was received for the scheme for implementation through SNA SPARSH and there was an immediate necessity to onboard the schemes in SNA SPARSH , SG account was

opened and transaction to SNA account was withheld . As per office memorandum read as 1st paper above, the unspent balance lying in SNA as well as State Treasury has to be remitted to the Consolidated Fund of Government. Hence Director of Agriculture has requested Government to accord permission to credit ₹16.0001 lakh being the Central share of funds lying in State treasury to the SNA account by providing additional authorisation.

3. Government have examined the matter in detail and are pleased to accord sanction to the Director of Agriculture for refunding an amount of **₹16.0001 lakh** being the Central share of funds lying in State Treasury as follows:
