It is informed that fund from different sources is estimated to be 356.45943 lakhs, while the total expenditure comes to Rs. 387.6673 lakhs and the deficit in fund amounting to Rs. 31.20787 lakhs be obtained through reallocation from 2435-01-101-73 (Plan) Green Coconut Procurement through VFPCCK. Hence Director has requested to accord Administrative Sanction for a total amount of Rs. 387.6673 lakhs (Rupees Three Crores Eighty seven lakhs Sixty six thousand seven hundred and thirty only) for the conduct of VAIGA 2026.
