In view of the General Election to Lok Sabha (HPCs)-2024, Government are pleased to fix the hire charges of Light and Heavy (Private) vehicles engaged for Election duty as follows :

2) The rates of hire charges sanctioned above are inclusive of all charges like cost of petrol / diesel etc. Drivers of the vehicles shall be provided with a food allowance of Rs.250/- (Rupees two hundred and fifty only) per day and an allowance (bata) of Rs.100/- (Rupees Hundred only) per day.
