### ORDER

Kerala State Women's Development Corporation has a total budget allocation of Rs. 1500 lakh under the H/a: 2235-02-190-99 for Ongoing Schemes in the FY 2025-26. Out of the same, Government have accorded administrative sanction for an amount of Rs. 775 lakhs for the implementation of various projects under this scheme as per the G.O. read as 1<sup>st</sup> paper above. Managing Director, Kerala State Women's Development Corporation as per the letter read as 2<sup>nd</sup> paper above, has requested to the release the sanctioned amount of Rs.7,75,00,000/- (Rupees Seven Crore Seventy Five Lakhs Only) to KSWDC's PSTSB A/a No.512 with District Treasury Thiruvananthapuram to ensure the continuous implementation of the Ongoing Schemes.
