## <u>ORDER</u>

Government, as per order read as 1<sup>st</sup> paper above, have accorded administrative sanction for an amount of Rs.96,00,00,000/- towards housing for police personnel or as a part of Police Stations in Urban Area, under the Scheme 'Special Assistance to States for Capital Investment 2023-24'. As part of implementing this Scheme, Government of India has informed that Rs.48 Crore will be released as 1<sup>st</sup> installment and the second installment of remaining 50% will be released by Government of India based on the progress made in the utilisation of 1<sup>st</sup> installment. Accordingly sanction has been accorded to transfer the first installment to SNA as per Government order read as 2<sup>nd</sup> paper above.

2) The State Police Chief, as per letter read as 4 th paper above, has

requested to allot the 2<sup>nd</sup> installment of Rs.48 Crore received from the Government of India as per letter read as 3<sup>rd</sup> paper above, and to issue a release order for transferring the same to the respective Single Nodal Account (SNA) for expenditure via PFMS. As per Government order read as 5<sup>th</sup> paper above, an amount of Rs.48 Crore has been additionally authorised under the Head of Account '4055-00-211-96-00-00-00-P-V', for transferring the 2<sup>nd</sup> installment to the SNA account of the scheme 'Special Assistance to States for Capital Investment for the Year 2023-24', for increasing the housing facility for the Police personnel and their families in Urban Areas.

- 3) Government have examined the matter in detail and are pleased to accord sanction for transferring an amount of Rs.48,00,00,000/- (Rupees Forty Eight Crore Only) under the head of account '4055-00-211-96-00-00-00-PV Housing for police personnel or as part of Police Stations in urban areas (PV)' to the SNA Account of the scheme 'Special Assistance to States for Capital Investment for the Year 2023-24'.
- 4) The SNA Officer shall adhere to the guidelines and instructions issued by the Central Ministry and the State Government from time to time.
