ORDER

Hence, the Director has requested for allotment of the Innova Crysta vehicle bearing registration number KL-07-CP-2326 from the Tourism Garage to the Office of the Advocate General instead of the vehicle bearing registration number KL-07-CP-2272.

2326 from the Tourism Garage, instead of the vehicle bearing registration number KL-07-CP-2272, to the Office of the Advocate General, Ernakulam, with immediate effect.

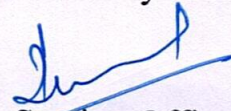
