**ORDER**

As per Government Order read as 1st paper above, Administrative Sanction was accorded for the Scheme " Assistance to Kerala State Warehousing Corporation (KSWC) -Construction of Godown cum Agriculture Complex " during the financial year 2022-23 for an amount of Rs. 100.00 Lakh under the head of account 4408-02-101-98-Plan.

As per the letter read as 2nd paper above, The Director of Agriculture & Farmer's Welfare Department has requested that an amount of Rs. 10.88498 Lakh ( Rupees Ten Lakh Eighty Eight thousand Four Hundred and Ninety Eight only) may be additionally sanctioned for the Scheme " Assistance to Kerala State Warehousing Corporation (KSWC) -Construction of Godown cum Agriculture Complex towards head of account 4408-02-101-98-Plan through additional authorization for settling the final bill in respect of the work 'Construction of Godown cum Agri complex'.

In view of the request of the Director of Agriculture, an amount of Rs.9,89,000 (Rupees Nine Lakh Eighty Nine Thousand Only) has been additionally authorized vide Government order read as 3rd paper above under the Head of Account 4408-02-101-98 -ASSISTANCE TO KERALA STATE WARE HOUSING CORPORATION FOR CONSTRUCTION OF GODOWN CUM AGRI COMPLEX -Plan.
