ORDER

As per the Government order read 1st above Administrative sanction amounting to Rs. 24,07,82,850 (Rupees Twenty- Four Crore Seven Lakh Eighty-Two Thousand Eight Hundred and Fifty only) have been accorded for the annual plan schemes of the Kerala State Science & Technology Museum for 2025-26 under the Head of Account 2203-00-112-61-36- Grant-in-Aid-General-Non Salary-P-V.

- 2. As per the Government Order read 2nd above, an amount of Rs. 3,00,00,000 (Rupees Three Crore only) was released to the Kerala State Science & Technology Museum as the first installment of Grant-in- Aid.
- 3. As per the letter read 3rd above, Director, Kerala State Science & Technology has requested to release balance amount of the plan fund for the timely implementation of various plan schemes.

Government have examined the matter in detail and are pleased to release an amount of Rs. 6,80,00,000/- (Six Crore Eighty Lakh only) as the 2nd installment of Grant-in-Aid for the financial year 2025-26 under the Head of Account 2203-00-112-61-36-Grant-in-Aid-General-Non Salary (Plan) by crediting the amount to the PSTSB account (799012700001438) of Kerala State Science & Technology Museum maintained at District Treasury, Thiruvananthapuram

5. The Director, Kerala State Science and Technology Museum, shall submit the utilisation certificate and expenditure statement for the released amount before any further release of funds.

6. The Director shall also take timely steps to furnish the audited accounts to the Government.
