ORDER

As per the Government Order read as 3rd above, administrative sanction has been accorded to the project proposal on out turn ratio of rice entitled "Varietal variation to out turn ratio of rice at varying stages of harvest and method of processing" submitted by the Director of Research, Kerala Agricultural University for an amount of Rs. 4 Lakhs only (Rupees Four Lakhs only) from the Head of Head of Account 2435-01-101-85 Plan subject to certain conditions. One of the condition laid down in the Government Order is that the implementation of the project will be managed by the Additional Director of Agriculture (Marketing) at the Directorate of Agriculture and the project implementation shall be completed by

31.03.2024.

2) As per the paper read as 4th above, the Director of Research, Kerala Agricultural University has informed that in Palakkad district, the samples can be collected only during virippu season,ie, August-September and the sampling and analysis will be completed by October 2024. Hence,it is requested to extend the time period for implementation of the project entitled 'Varietal variation to out turn ratio of rice at varying stages of harvest and method of processing' up to October 2024.

3) Accordingly, as per the Government Order read as 5th above, revised administrative Sanction has been accorded to extend the time period for implementation of the project proposal on out turn ratio of rice entitled "Varietal variation to out turn ratio of rice at varying stages of harvest and method of processing" submitted by the Director of Research, Kerala Agricultural University up to 31.10.2024.

4) As per the paper read as 7th above, the Director of Research ,Kerala Agricultural University has informed that , since NIFTEM, Thanjavur, wherein the paddy samples were to be got analysed for shelling , milling and par boiling , doubled the rate of sample analysis, in addition to the amount of Rs. 4.0 Lakhs (Four Lakh Rupees only) already released for the project "Varietal variation to out turn ratio of rice at varying stages of harvest and method of processing", an additional amount of Rs. 6.6 Lakhs (Six Lakh Sixty Thousand Rupees only) is required for the completion of the project and has requested to sanction the same.

5) Government have examined the matter in detail and are pleased to accord administrative Sanction for an additional amount of Rs. 6.6 Lakhs (Six Lakh Sixty Thousand Rupees only) for the completion of the project proposal on out turn ratio of rice entitled " Varietal variation to out turn ratio of rice at varying stages of harvest and method of processing" submitted by the Director of Research, Kerala Agricultural University. Sanction is also accorded to extend the time period of the project by eight months from the date of execution of the MoU between the Registrar, Kerala Agricultural University and the Director, Agriculture Development and Farmers Welfare Department.
