**ORDER**

In the current year's budget an amount of Rs.200 lakhs has been earmarked to Energy Management Centre (EMC) under the head of account "2801-80-004-99-00-00-0-P-V". Subsequently vide G.O read as 2<sup>nd</sup> paper above, Government have accorded administrative sanction for the implementation of Small Hydro Power Development and Hydro Kinetic Power Project for an amount of Rs.169.79 lakhs.Further vide G.O read as 1<sup>st</sup> paper above, Government released the resumed fund of Rs.30.21 lakhs under the head of account "2801-80-004-99-00-00-0-P-V" from the previous financial year (2024-2025) to the current year, which has been fully utilized by EMC.

2) The Director, EMC vide letter read as 3rd paper above has requested to release an amount of Rs.84.89 Lakhs (Rupees Eighty Four Lakhs and Eighty Nine Thousand Only) from the plan fund under the head of account "2801-80-004-99-00-00-0-P-V" Small Hydro Power Development and Hydro Kinetic Power Project.

3) Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs. 39.79 Lakh

(Rupees Thirty Nine Lakhs and Seventy Nine Thousand only) from the plan fund under the head of account "2801-80-004-99-00-0-P-V" Small Hydro Power Development and Hydro Kinetic Power Project for the year 2025-26 subject to the conditions specified below:

1.The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.

2.The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.

3.The Director Energy Management Centre shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.

4.If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
