**ORDER**

Government of India, as per letter read as 1<sup>st</sup> paper above, allocated central financial assistance of Rs.50,00,00,000/-(Rupees Fifty Crore only) (as 2<sup>nd</sup> instalment) to the Government of Kerala during the financial year 2025-26 for development of fisheries in the State under the Pradhan Mantri Matsya Sampada Yojana (PMMSY).

2. The Director of Fisheries, as per letter read as 2<sup>nd</sup> paper above, informed that since the central fund allotted is Rs.50 crore, the corresponding state share will be Rs.33.333 crore, thus total an amount of Rs.83.333 crore needs to be sanctioned for the time bound and smooth implementation of the project under PMMSY. Hence requested for re- appropriation and sanction for utilization of fund. The statistics of funds in different heads that to be mapped under PMMSY are as follows:

3. The Director of Fisheries, as per letter read as 3<sup>rd</sup> paper above, requested that the fund be allotted as an additional authorization, instead of re-appropriation as there is no necessary funds available under any plan head for this current financial year for re-appropriation.

Government have examined the matter in detail and are pleased to accord sanction for additional authorization of an amount of **Rs.48.418 (Rupees Forty Eight Crore Forty One Lakh Eighty Thousand Only)** as per G.O read above and for utilization of **Rs.83.333 crore (Rupees Eighty Three Crore Thirty Three Lakh and Thirty Thousand Only)** for the implementation of the PMMSY scheme through SNA SPARSH.

5. The Director of Fisheries will take timely steps to regularise this additional expenditure through Reappropriation of Savings within the Grant/Supplementary Demands for Grants before the close of the current financial year.
