ORDER

As per the order read 1st above Administrative sanction amounting to ₹ 24,07,82,850 (Rupees Twenty- Four Crore Seven Lakh Eighty-Two Thousand Eight Hundred and Fifty only) has been accorded for the annual plan schemes of the Kerala State Science & Technology Museum for 2025-26 under the Head of Account 2203-00-112-61-36-Grant-in-Aid-General-Non Salary-P-V.

2) As per the orders read 2nd and 3rd above, sanction was accorded for releasing ₹3 crore and ₹6.80 crore respectively to the Kerala State Science & Technology Museum as the first and second installments of Grant-in-Aid.

3) Now, Government are pleased to accord sanction to release an amount of ₹. 5,00,00,000/- (Five Crore only) exclusively for the developmental activities of Science City, Kottayam as the 3rd installment of Grant-in-Aid for the financial year 2025-26 under the Head of Account 2203-00-112-61-36-Grant-in-Aid-General-Non Salary (Plan) by crediting the amount to the PSTSB account (799012700001438) of Kerala State Science & Technology Museum maintained at District Treasury, Thiruvananthapuram.

4) The Director, KSSTM, shall ensure that the amount of ₹5 crore is

utilised only for the works that have received Administrative Sanction under the Kottayam Science City project during the current financial year.

5) The Director, Kerala State Science and Technology Museum, shall submit the utilisation certificate and expenditure statement for the released amount before any further release of funds.

7) The Director shall also take timely steps to furnish the audited accounts to the Government.
