ORDER

As per the G.O read as 1st paper above, Administrative Sanction for an amount of ₹.3.465 crore was issued for the NPPMBI for the Burns unit at GMC Kozhikkode. Later an amount of ₹.2.079 crores was released as 1st installment and transferred to KMSCL for execution of civil works and procurement of equipment. As per Government Order read as 2nd paper above, an additional amount of ₹.83.90 lakh (Central share) and ₹.55.40 lakh (State share) (*total ₹.139.30 crores*) was released towards the balance requirement for completion of the approved project components.

2) As per the letter read as 3rd paper above, the Director of Medical Education has proposed to utilise an amount of ₹.1,28,99,480/- for procurement of essential equipment and ₹.10,00,000/- for completion of residual civil works required for the burns unit (*total Rs.138.99 crores*) and to accord A.S for an amount of ₹.38,47,000/- for the procurement of equipment. It has also requested to accord permission to transfer an amount of ₹.90,52,480/- to KMSCL for the procurement of equipment and to transfer an amount of ₹.10,00,000/- to KMSCL towards completion of residual civil works for the above project.

3) Government have examined the matter in detail and are pleased to accord Administrative Sanction for transferring an amount of ₹.90,52,480/- (Rupees Ninety Lakh Fifty Two Thousand Four Hundred and Eighty only) to KMSCL for the procurement of equipment as per the following;
