ORDER

As per G.O read as 1st paper above, Administrative Sanction was issued for an amount of ₹ 90,52,480/- for the procurement of equipment and the permission was accorded to transfer the said amount to KMSCL. Administrative Sanction was also accorded for an amount of ₹ 38,47,000/- for the procurement of equipment and permission was also accorded to transfer the said amount to KMSCL. Moreover, permission was also accorded for Transferring an amount of ₹10,00,000/- (Rupees Ten Lakh only) to KMSCL towards completion of residual civil works connected with the Burns Unit.

2) In the A.S order it was misstated that permission was also accorded to transfer an amount of ₹38,47,000/- to KMSCL in addition to ₹90,52,480/- for the procurement of equipments. As per the letter read as 2nd paper above, the Director of Medical Education has requested to modify the Administrative Sanction order by rectifying the same.

3) Government have examined the matter in detail and are pleased to modify the Administrative Sanction order as per the following;

1. Administrative Sanction is accorded for procurement of equipment

1. Administrative sanction is accorded for procurement of essential equipments to a tune of ₹ 90,52,480/- connected with the Burns Unit at Government Medical College, Kozhikode through KMSCL and to transfer the fund to KMSCL.
2. Administrative Sanction is accorded for the Procurement of remaining items to a tune of ₹ 38,47,000/- connected with the Burns Unit at Government Medical College, Kozhikode by the Principal, Government Medical College, Kozhikode.
