### ORDER

Government have accorded administrative sanction for an amount of Rs.87,000/- for conducting the Narco Analysis Test of a suspect in CB Cr. No. 257/CB/EKM/R/21 U/s at Forensic Science Lab, Gandhinagar, Gujarat under the head of account of "2055-00-101-99-34-Other charges" as per Government order read as 1<sup>st</sup> paper above. Later the State Police Chief as per the letter read as 2<sup>nd</sup> paper above has informed that the SP Crime Branch, Ernakulam has reported that earlier sanctioned amount of Rs.87,000/- could not be utilized due to treasury restrictions and the said amount has been surrendered. The SP Crime Branch has also submitted that as per the latest rate of service charge stipulated by the DFSL Gujarat, an amount of Rs.1,15,470/- is required for conducting the Narco Analysis Test of the suspect in CB Cr. No. 257/CB/EKM/R/21 at Forensic Science Lab, Gandhinagar Gujarat. This estimate include, modified fees for the Narco Analysis test @ Rs.80,525/-plus 18% GST, transportation charges of suspect, and the charges of Translator.

2) The State Police Chief has therefore requested to accord administrative sanction to incur an expenditure of Rs.1,15,470/- under the head of account of "2055-00-101-99-34-Other charges" and to allot the sufficient fund.

3) Government have examined the matter in detail and are pleased to accord revised administrative sanction for an amount of Rs.1,15,470/- (Rupees One Lakh Fifteen Thousand Four Hundred and Seventy Only) under the head of account "2055-00-101-99-34-Other charges" for conducting the Narco Analysis test of a suspect in CB Cr No.257/CB/EKM/R/21.

4) An amount of Rs. 1,16,000/- (Rupees One Lakh and Sixteen Thousand Only) has been additionally authorised under the head of account 2055-00-101-99-34-3-N-V as per Government order read as 3<sup>rd</sup> paper above.
