**ORDER**

As per the order read as 4<sup>th</sup> paper above administrative sanction  
was accorded for an amount of ₹14 lakh for setting up of Women Help  
Desks in Police Stations, at the rate of ₹1 lakh per station, debiting the  
expenditure to the Head of Account 2055-00- 109-90-PV.

The State Police Chief, as per the letter read as 5<sup>th</sup> paper above ,  
informed that as per the Guidelines issued by the Ministry of Finance  
read as 1<sup>st</sup> paper above, Government of India have issued revised  
procedure for flow of funds under Central Sector Schemes and  
monitoring of utilization of funds released. The Women Help Desk  
Scheme has been implemented as a Central Nodal Agency(CNA)  
project. The National Crime Records Bureau (NCRB) has been  
designated as the Central Nodal Agency(CNA) for Women Help Desk.  
Hence Fund was released to the State Government only by National

Crime Records Bureau (NCRB) through PFMS. As per the direction of MHA, Kerala Police Department have opened a Zero Balance Child Account with CNA's Bank.

The State Police Chief has requested to provide necessary clarification or accord a revised administrative sanction to utilize Rs.14 Lakh for the FY 2025-26 through PFMS according to the detailed procedures issued by the Ministry of Finance so as to utilize the funds in this financial year itself.

Government, after examining the matter in detail, are pleased to accord sanction for utilization of ₹14 Lakhs during the FY 2025–26 through PFMS, in accordance with the detailed procedures issued by the Ministry of Finance, as per the order read as 1<sup>st</sup> paper above, so as to ensure utilization of the funds in this financial year itself.
