### ORDER

3. The event was expected to feature international riders from more than 13 countries, large franchise teams, and extensive national/international media coverage. The organisers had highlighted that the event will significantly contribute to tourism

visibility, hospitality-sector activity, and youth engagement in the State.

Government have examined the matter in detail and taking into account the tourism potential of the event, are pleased to accord sanction to the Director of Tourism to expend an amount of ₹10,00,000/- (Rupees Ten Lakhs Only) towards the conduct of an official round of the League- the Grand Finale of the league on 20th & 21st December 2025 at EMS Stadium, Kozhikode , under the auspices of *Indian Supercross Racing League (ISRL)* in association with Bandidos Motorsports the *with Kerala Tourism as the Official State Partner* , **subject to ensuring adequate funds through re appropriation/additional authorization in the Head of Account 3452-80-104-98-00-34-03 – PV Marketing.**

5. The Directors Super cross India Pvt Ltd shall furnish a Utilization Certificate to the Director of Tourism within three months of receiving the sanctioned amount and the Director of Tourism shall verify the authenticity of the Utilisation Certificate.
