## **ORDER**

The State of Kerala has seen a marked shift towards increased allocation to infrastructure and development projects. Project implementation processes and timeliness can be significantly improved with better co-ordination and rapport between multiple departments, local bodies and other stakeholders. In order to ensure that development works do not get unduly delayed and are implemented in the shortest possible time, it is proposed to strengthen the existing institutional mechanism at State and District levels. As per G.O. read as 5<sup>th</sup> above, guidelines were issued for strengthening the project reviewing and monitoring mechanism for effective implementation of priority projects so as to prevent avoidable delays and ensure brisk implementation of projects.

- (2) In order to monitor High Valued Projects being implemented in the State, Government have decided to create the posts of Project Co-ordinator and Junior Resource Person.
- (3) Government have examined the matter in detail and are pleased to accord sanction to create the following 16 posts on contract basis:
