ORDER

The Managing Director, Kerala Forest Development Corporation, as per the letter read as 6th paper above, has forwarded the application with necessary documents submitted by Sri.Kannan.P.M (S/o Late Ammini, Part Time Sweeper, Kerala Forest Development Corporation) for employment assistance under the Compassionate Employment Scheme. The applicant's mother Ammini, died on 07.02.2016 while in service.

2) The 208th meeting of Board of Directors held on 31.12.2020 accorded permission to submit the application received from Sri.Kannan.P.M, Puthenveettil house, Thrikkur - 680 306, to Government. The Managing

Director, Kerala Forest Development Corporation, as per the letter read as 6th paper above and the District Collector, Thrissur as per the letter read as 5th paper above have recommended the application.

- 3) Sri.Kannan.P.M, is found eligible for employment assistance in Government service as he satisfies all the conditions stipulated in the Government Order read as 1st, 2nd and 3rd papers above. The applicant has completed 36 years of age, as his date of birth being 12.09.1985. He has passed SSLC Examination and has applied for the post of Office Attendant in Kerala Forest Development Corporation. Smt.Manju, daughter of late Smt. Ammini has given her consent and No objection in giving employment to Sri.Kannan P.M. As per the income certificate issued by the Kallur Village Officer and which submitted by the applicant the annual income is ₹ 72000/- only (Rupees seventy two thousand only) which is well below the admissible ceiling of 8 lakhs per annum.
- 4) In the above circumstances, sanction is accorded for the appointment of Sri. Kannan P.M., son of Smt. Ammini (Late), (Formerly Part-Time Sweeper in KFDC) in the post of Office Attendant in Kerala Forest Development Corporation, under the Compassionate Employment Scheme, against the existing or arising vacancy.
- 5) The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of submission of the application or during the course of enquiry conducted by the Department.
- 6) The Managing Director, Kerala Forest Development Corporation will issue necessary posting orders to Sri.Kannan.P.M subject to verification of his original documents to prove age, educational qualification, medical fitness,

character and subject to the conditions stipulated in Government Order read 1st, 2nd and 3rd paper above, also subject to all other conditions under the scheme in force. Necessary entries in this regard will be made in the Service Book of the deceased employee by the Managing Director, Kerala Forest Development Corporation.
