**ORDER**

Administrative Sanction was accorded for the work - IDK-Providing BM & BC to Vattappara Thovala Road km 0/000 to 2/500 for an estimated amount of Rs. 300 lakhs (Rupees Three Hundred Lakhs only) under the H/A 3054-03-337-98(NP) vide Government Order read as 1st paper above.

2. Later the Chief Engineer PWD Roads reworked the proposal and changed the scope of the work after incorporating the recommendations of the CTE and requested to accord Revised Administrative Sanction for the reworked proposal and to change the name of the work as "GENERAL-RP Vattappara-Thovala road-Providing 40mm Close graded premix surfacing to Vattappara-Thovala road Ch 0/000 to 2/284." vide letters read as 2nd papers above.

3. Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction for changing the scope of work and changing the name of work to "GENERAL-RP Vattappara-Thovala road-Providing 40mm Close graded premix surfacing to Vattappara- Thovala road Ch 0/000 to 2/284" at agreed rate ie, 2,70,10,000/- (Rupees Two Crore Seventy Lakh and Ten Thousand only) subject to the condition that TS authority shall ensure that no undue benefit accrues to contractor due to the variations ordered under the h/a 3054-03-337-98(NP).
