ORDER

As per the Government Order read as 1st paper above Administrative Sanction was accorded to the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd, for launching Coaching Assistance schemes to the students/applicants belonging to the economically weaker sections among the forward communities of Kerala for the financial year 2024-25, at an estimated cost of Rs.250 lakh, meeting the expenditure from the head of account '2235-02-190-97-34-OC-P provided in the current year's budget.

2. As per letter read as 2nd paper above Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd has requested to release an amount of Rs.250 Lakh for the successful implementation of the Coaching assistance schemes.

Government have examined the matter in detail and are pleased to release an amount of Rs.75 Lakh (Rupees Seventy five Lakh only) as 1st installment to Kerala State Welfare Corporation for Forward Communities Ltd, under the head of account '2235-02-190-97-34-OC(P)' for meeting the expenses in connection with the Coaching Assistance schemes launched by the Corporation subject to the terms and conditions mentioned below.

*	The Corporation shall furnish duly authenticated detailed component wise statement of Expenditure and Utilization Certificate in the prescribed form as

*	appended to the GO(MS)No.4/2020/Fin dated 09.01.2020. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
