ORDER

Administrative Sanction for various Continuing Schemes for the Financial Year 2026-27 was accorded as per the Government Orders read as 1st and 2nd papers above. As per the letter read as 3rd paper above, the Director, Scheduled Castes Development Department, submitted a revised proposal seeking Administrative Sanction for the continuing State Plan Schemes and Centrally Sponsored Schemes (CSS) for FY 2026-27, based on the Memorandum of Alterations to the Original Budget Estimate 2026-27.
