ORDER

As per the Government Orders read as 1st to 8th above, Administrative Sanction/Revised Administrative Sanction was accorded from time to time for the implementation of the project "New Product Development,

Office Automation, Virtual Exhibitions, CFC Strengthening, etc." of the Handicrafts Development Corporation of Kerala Ltd. (HDCK), and funds were released in phases. Subsequently, Government, as per the order read as 8th above, revalidated the Administrative Sanction for the project during the financial year 2025-26, limiting the expenditure to ₹188 Lakh from the Plan Fund. However, the sanctioned amount could not be released during the financial year 2025-26.

2) An amount of ₹200 Lakh has been provided in the Budget Estimates 2026-27 under the Head of Account 6851-00-190-98-P – Rejuvenation and Revival of Viable Public Sector Units for the project "Installation of Design Centre and New Products Development."

3) The Member Secretary, Board for Public Sector Transformation (BPT), Thiruvananthapuram, as per the letter read as 9th above, has forwarded a proposal seeking revalidation of the Administrative Sanction for the ongoing project "Installation of Design Centre and New Products Development" of HDCK for an amount of ₹188 Lakh under the Scheme "Rejuvenation and Revival of Viable Public Sector Units" during the financial year 2026-27.
