ORDER

The Director of Industries & Commerce, Thiruvananthapuram, has forwarded a project proposal for Infrastructure Upgradation of Northern Regional Office, Kozhikode (Palayam) of Kerala Artisans Development Corporation Ltd (KADCO) under the Scheme "Assistance to Apex Organizations in Handicrafts Sector" at an estimated cost of ₹34.46, Lakh from the current year's budget provision under the Head of Account 4851-00-104-99-P.

2) An amount of ₹50.00 Lakh has been provided in the Budget Estimates 2026-27 under the Head of Account 4851-00-104-99-P for extending capital assistance to SURABHI, HDCK, KELPALM and KADCO towards technology upgradation, modernization, renovation and other capital-intensive activities. The provision also includes the renovation of selected outlets.

3) The project proposes essential infrastructure works including civil works, interior furnishing, networking setup, and office cabins/workstations to make the premises fully functional. As the Kozhikode Regional Office is the largest unit of the Corporation in terms of sales turnover, the proposed upgradation is considered essential for improving its operational efficiency.

4) The Working Group Meeting of the Industries Department held on 08.07.2026 considered the above proposal and recommended to accord Administrative Sanction for the implementation of the project at a cost of ₹12.50 Lakh under the Head of Account 4851-00-104- 99-P from the current year's budget provision.

5) In pursuance of the above, Government have examined the matter in detail and are pleased to accord Administrative Sanction for the implementation of the project "Infrastructure Upgradation of Northern Regional Office, Kozhikode (Palayam)" of Kerala Artisans Development Corporation Ltd (KADCO) for an amount of ₹12.50 Lakh (Rupees Twelve Lakh and Fifty Thousand Only) from the Plan Fund, limiting the expenditure to the current year's (2026-27) budget provision under the Head of Account 4851-00-104-99-P.

6) All purchases shall be made subject to the strict observance of the Kerala Stores Purchase Rules.

7) The Managing Director, Kerala Artisans Development Corporation

Ltd (KADCO), shall forward the proposal for release of funds at the appropriate time.
