ORDER

The Director of Industries and Commerce, Thiruvananthapuram, has forwarded a project proposal submitted by the Handicrafts Development Corporation of Kerala Ltd. (HDCK) for the Modernization of the Common Facility Service Centre (CFSC) at Attakkulangara, Thiruvananthapuram, under the scheme "Establishment of Common Facility Service Centres for Handicrafts". The project envisages modernization of the existing Common Facility Service Centre with a total estimated cost of ₹25.20 Lakh, and seeks Government assistance of ₹12.50 Lakh from the Budget Provision for the financial year 2026–27 under the Head of Account 2851-00-104-86-P.

2) The proposed modernization of the CFSC is intended to strengthen the infrastructure and facilities available to artisans, thereby improving productivity, promoting innovation in handicrafts, generating employment opportunities and enabling artisans to cater to changing consumer preferences and expand the market for Kerala handicrafts in both domestic

and international markets.
