### ORDER

An amount of Rs.11.50 Crore was provided under the Head of Account 2215-01-800-64-P(V) for the implementation of the scheme 'Scaling up of Rain Water Harvesting and Ground Water Recharge programme' for the year 2025-26. Administrative Sanction was accorded as per Government Order read as 2nd paper above. An amount of Rs. 104.78 lakh was already released as per Government Order read as 1st paper above and Rs. 103.94 lakh has been utilized.

2.The Executive Director, Jalandhi as per letter read as 3<sup>rd</sup> paper above, has requested to release the balance amount of Rs.10,45,22,000/- (Rupees Ten Crore Forty five lakh and Twenty two thousand only) from the budget provision under the Head of Account 2215-01-800-64 (State Plan) for timely settlement of pending bills and smooth implementation of the ongoing and proposed activities under the programme.

3. Government have examined the matter in detail and are pleased to release an amount of Rs.171.88 lakh (Rs.85.63 lakh for clearing pending bills and Rs.86.25 lakh being half of the administrative expenses) under the Head of Account 2215-01-800-64 (P) — Scaling up of Rain Water

Harvesting and Ground Water Recharge Programme, subject to the following terms and conditions:

1. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
2. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
3. The Executive Director, Jalandhi shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
4. If there is un-utilized amount at the end of this financial year that should be refunded to the government during the financial year itself.
