ORDER

As per the reference 1st cited, the Government of India has issued a mother sanction for an amount of Rs.46,60,000/- (Rupees Forty Six Lakh Sixty Thousand only) towards the procurement of equipments for the Burns Unit, Govt. Medical College Thrissur under the CSS "National Programme for Prevention and Management of Burn Injuries (NPPMBI)"(60:40). As per the letter read as 2nd paper above, the Director of Medical Education has requested to allot the Central Share along with the corresponding State Share for the implementation of the project. As per the G.O read as 3rd paper above, Government have additionally authorised an amount of Rs.77,70,000/- under the HoA "2210-05-105-28-04 (PV) for the scheme.

2) Government have examined the matter in detail and are pleased to release an amount of Rs.77,70,000/- (Rupees Seventy Seven Lakh Seventy Thousand only) (including Central Share for an amount of Rs.46,60,000/- and State Share for an amount of Rs.31,10,000/-) under the HoA "2210-05-105-28-04 (PV) for the procurement of equipment for the National Programme for Prevention and Management

of Burn Injuries (NPPMBI)" at Govt. Medical College Thrissur.

3) The Director of Medical Education will take timely steps to regularize this additional expenditure through re-appropriation of savings within the Grant/Supplementary Demands for Grants before the close of the current financial year.

4) The Director of Medical Education shall furnish Utilization Certificate in time bound manner.
