ORDER

Government, as per G.O. read above, accorded Administrative Sanction for the Project 'Interest Subvention to Fishermen for Fishing Inputs and to Women for Fish Vending (2025-26) ' at a total cost of Rs.400 lakh (Rupees Four Crore only).

2.The Director of Fisheries, as per letter read above,has requested to sanction the release of an amount of Rs.400 lakh (Rupees Four hundred lakh only) under head of account 2405-00-103-80(P) to Managing Director, Matsyafed for implementation of the said project.

3.Government have examined the matter in detail and are pleased to release **Rs.200 lakh(Rupees Two Crore only)** under H/A 2405-00-103-80-(P), for implementing the project "Interest Subvention to fishermen for procuring fishing inputs and to women fish vendors for fish vending" subject to usual terms and conditions of fund release as below and also subject to the condition that 1/2 of the allocation should be utilised for the interest subvention of women fish vendors as stipulated in the plan write up.

- i. The amount shall not be parked in Banks / Financial Institutions other than Treasuries as non interest bearing PSTSB accounts.
- ii. The instructions stipulated in Circular No.75/09/fin dated 29/08/09 circular No. 84/2008/Fin dated 09/12/08 shall be scrupulously followed.
- iii. The Administrative Department shall furnish duly authenticated detailed component wise statement of Expenditure and Utilization Certificate in the prescribed form as appended to the GO(MS)No.4/2020/Fin dated 09.01.2020.
- iv. If there is unutilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
