### ORDER

Government have allocated an amount of Rs15,00,00,000/(Rupees Fifteen Crore) to the Kerala Khadi and Village Industries Board towards special rebate on retail sale of Khadi under the H/a 2851-00-105-96-33-Subsidies in the current financial year. Out of this, an amount of Rs 405 Lakh( Rupees Four Hundred and Five Lakh only has) been released as per G O read as 1<sup>st</sup> paper above and Rs 45 Lakh(Rupees Forty Five Lakh Only ) has been released as per GO reed as 2<sup>nd</sup> paper above.

2.Now as per the letter reed as 3<sup>rd</sup> paper above,Secretary,Kerala Khadi and Village Industries Board has requested to release an amount of Rs.10,50,00,000/-(Rupees Ten Crore Fifty Lakh only) towards special rebate on retail sale of khadi for the year 2024-25 under the H/A of 2851-00-105-96-33susbsidies.

3.Government have examined the matter in detail and are pleased to release an amount of **Rs 375 Lakh (Rs Three Crore Seventy Five Lakh only)** to KKVIB under the H/A **2851-00-105-96-33- Special Rebate on Retail sale of Khadi-Subsidies (NP)**' towards third installment of fund for Special Rebate on Retail Sale of Khadi, from the budget provision for the current Financial Year (2024-25), on the

following conditions:

- 1.Funds should not be parked in Banks or other Financial Institutions
- 2.Funds shall be utilised for the purpose for which it is released and not diverted for any other purpose.
- 3.The procedures prescribed in Cir No.84/2008/Fin dated 09.12.2008, Cir No.75/2009/Fin dated 29.08.2009, Cir No.8/2018/Fin dated 30.01.2018 and Cir No.53/2018/Fin dated 16.06.20218 should be scrupulously followed.
4. Utilisation Certificate/Component wise expenditure details in respect of the previous releases as well as the amount to be released should be furnished in the prescribed format appended with G O (Ms) 04/2020/Fin dated 09/01/2020 along with further fund release proposals.
- 5.The conditions stipulated in G O (P) No.157/2021/Fin dated 26.11.2021 & G O (P) No.171/2021/Fin dated 18.12.2021 in respect of the Loan Monitoring and Fund Management System should be scrupulously followed.
6. Arrears would be paid only for Kerala State produce and the Kerala Khadi and Village Industries Board should give data for that.

4.The Bill presented by the Secretary,Kerala Khadi and Village Industries Board will be countersigned by the Director/Additional Director of Industries and Commerce.
